PLAGIARISM RULES OF TUMKUR UNIVERSITY

Soft copy of the doctoral theses (preferably in CD-ROM/ DVD) covering all the chapters including bibliography/references has to be submitted in a single readable PDF file, excluding preliminary pages: declaration, acknowledgement, abstract, list of charts and abbreviations, table of contents etc., and succeeding pages: glossary, index, questionnaire etc., to the University Librarian/Deputy librarian who will also be the co-ordinator of the the Shodhganga Project.

- A. The candidate has to enclose the permission letter issued by the University for checking plagiarism his / her communication to the University Librarian and a copy of the same has to be submitted to the Director Research, Tumkur University, Tumkur.
- B. The University library through the Shodhganga Project and INFLIBNET has to check the content of the thesis with anti-plagiarism software. At present "URKUND" is the anti-plagiarism software which is being used by the UGC INFLIBNET. The use of a anti-plagiarism software can change from time-to-time depending on the choice offered by UGC INFLIBNET and on the orders issued by the University.
- C. The limit for plagiarism or percentage of similarity allowed is up-to 25 % of similarity index for doctoral thesis. 5 % additional similarity shall be allowed for own content from publications provided the guide and the candidate produce a certificate of publication along with original article.
- D. The full report of the plagiarism check shall be submitted by the Librarian to the Registrar along with soft copy of the same to the concerned candidate and the guide.
- E. In case the percentage of similar content detected is beyond 30 percent (includes 25+5 %), then the said candidate and the guide have to revise and resubmit the theses for plagiarism checking within two months. It is the responsibility on the part of the candidate and the Guide to go through the identified similar content (plagiarized) and take appropriate measures to ensure originality of the research output. A fee of rupees two thousand (Rs 2000) for the first time will be charged by the University, if the thesis is re-submitted a second time for plagiarism check a fee of rupees four thousand (Rs 4000) will be charged and if the content is more than 30 % in the second check, a final check may be allowed by the University with a fee a rupees ten thousand (Rs 10, 000) and if similar content of 30 % is found then the thesis will be rejected.
- F. For, those candidates who are submitting their thesis in languages like kannada, Sanskrit, Hindi, Utdu or any other regional language plagiarism checking is not mandatory as language specific anti-plagiarism detection software's are not available. However, such candidate before submission of thesis has to submit an undertaking also signed by the supervisor vouching that "there is no plagiarism".
- G. Any rules/modifications/software's available from time-to-time the same may be incorporated by the University for the betterment of plagiarism check and improving the quality of research out-put and the decision of the University is final and binding on all concerned.
